1. Welcome and apologies (Rebecca Hawkins)

Meeting commenced at 4.35pm
Rebecca welcomed those members present and thanked them for their attendance.

2. Confirmation of minutes from the Annual General Meeting 2020 (Rebecca Hawkins)

3. President's Report (Mandy Hudson)

Mandy acknowledged the work of the Executive this year.

Member survey 2021

The Association conducted a survey of members at the beginning of the year in relation to the services provided and the ways of working in 2020 due to COVID-19 restrictions. The two key findings were:

- members identified assessment tasks and semester examinations as a key deliverable for the Association
- members identified the benefit of targeted professional learning for teachers and students, delivered in a short time frame.

The Executive continued to carry out these activities in 2021.

Membership 2021

- The total number of school memberships was 107
- The revenue from membership was \$16, 645 (2020 \$13, 784)
- Note the growth in international membership and as an Association, we need to consider how to deliver services to these members moving forward
- The table on the next page references the breakdown of membership

Member communication

The Association refined the communication to members this year with a focus on

- Regular email updates through
 - the ETAWA website to provide targeted communication based on the audience and the Association will continue to improve on this in 2022 to use the membership data to target specific groups of teachers, and continue to provide links to the website in our communications
 - Facebook – minimal growth in 2021, and an area of focus for 2022
 - website (OnCord)
 - regular updates including frequency new sliders to promote specific events to tie in with member communication
 - integration between contracts and sales data (syncing invoices with Xero)
 - new analytics to inform use of website, e.g. visitors to the site, where they are from; improved search engine optimisation; unlimited website pages and blog post to communicate news and events

Business Educators Australasia (BEA)

- ETAWA is a member of this national association and pays approximately \$800 as affiliation fees based on membership numbers
- In 2021 BEA reviewed and developed the Strategic Plan for the next three years, to commence in 2022
- A key discussion at the BEA Council meeting, and the AGM, was in relation to the under representation of Economics within this national body
- No specific changes were able to be made to raise the profile of Economics or Economics and Business within this body, despite support for ETAWA's proposal by Queensland and NSW
- A consideration for the 2022 Executive is whether the Association continues to have an affiliation with BEA despite underrepresentation and to perhaps continue a partnership with the Economics Society of WA

Australian Curriculum Review

- ACARA reviewed the Australian Curriculum in 2021:
 - the School Curriculum and Standards Authority consulted widely in May to develop and provide the jurisdictional feedback on Humanities and Social Sciences for Western Australia
 - the Association provided specific feedback in writing on two occasions on the proposed changes to Economics and Business directly to ACARA, but also contributed to the national response developed by BEA
 - the Association also participated in three Zoom Meetings with representatives from ACARA to provide feedback on the proposed curriculum for Economics and Business, but also more broadly on the proposed changes to the Humanities and Social Sciences curriculum

PTCWA Professional Service Awards

- Chris' engagement with Economics Teachers' Association of Western Australia spanned over 40 years, including a number of varied roles within the Executive over this time
- Chris valued the professional association and the opportunities it could provide to teachers and for professional growth
- Chris was a pioneer in terms of building Economics, and Economics and Business, into everyday life
- Chris' premise for engaging students was unpretentious – to use relevant and authentic examples that help to explain economic concepts in simple terms using real contexts
- Chris was entrepreneurial and developed Econobites
- Chris was a role model for his colleagues and a mentor to those he worked with and it was fitting that he was the recipient, posthumously, of the PTCWA Professional Service Awards

COVID–19

- COVID-19 continued to have an impact on the type of events offered by the Association in 2021 and affiliate associations
- the recipients of the David King Scholarship for 2020 and 2021 have been unable to utilise the scholarship at this point in time
- uncertainty regarding venue hire and limitations on number, along with border restrictions, meant face-to-face events were again restricted in 2021, intrastate and interstate
- the Association continued to develop expertise in presenting events for teachers and students using different formats:
 - ZOOM Webinars for students and teachers, such as RBA presentations
 - Discounts and/or free online resources and/or webinars offered by affiliates such as CCIWA, Treasury, RBA and ESA

- 'Why study Economics' package of resources (teachers and students) – 4 page A4 brochure, posters and flyers; links to ESA and RBA videos 'Why Study Economics' available on the Association's website
- Examinations (teachers)
 - Semester 1 Year 11 (94) and Year 12 (86)
 - Semester 2 Year 11 Practice (40) Year 11 (92) and Year 12 (90)
 - Total revenue from examinations \$22, 920
- Good Answer Guide (teachers and students)
 - Printed Good Answer Guide 2020 – 85 copies sold, down from 150 in 2020
 - Total revenue from the Good Answer Guide \$3,400
- Chris Stone Econobites (teachers and students)
 - support the delivery of Economics and Business in Years 7 to 10 and Economics in Years 11 and 12 with current events linked directly to the syllabus content of each year
 - available on the public website and not limited to members only

Events and activities

- ATAR Student Revision Seminar (students)
 - Notre Dame University 104 students with 101 via ZOOM
- Cartoon Competition for HASS Week (students)
 - increased number of entries in 2021 across systems /sector
 - topics were Vaccine led recovery, Business responses during COVID–19 and The great reset
- CCIWA Student Forum (students)
 - as in 2020 the face to face was replaced with a set of data analysis questions that could be downloaded from the CCIWA website for teachers to use with students
- RBA Zoom Seminar (teachers and students)
 - 2 sessions offered over two weeks, one am and one pm with 52 registrations

The Association continued to build on its strong links with affiliates such as the RBA, Federal Treasury, CCIWA, Universities and the Association looks to new opportunities in 2022.

5. Life Membership Inductee (Mandy Hudson)

ETAWA has, since its inception, relied on the time and expertise of teachers who have volunteered to be involved in the Association and its activities. Over the past 50 years, six to ten members have each year given their time and effort to be on the executive of the Association which has benefited thousands of teachers of Economics.

The Association recognises the outstanding service of individuals through life Membership. Congratulations to Sunila Singh on her induction into the Association as a life Member.

4. Treasurer's Report (Andrea Fitzpatrick)

The Treasurer tabled the formal Financial Statements to the Association for review and acceptance.

Financial Position

Refer to accounting statements attached (Appendix B).

Over the year, ETAWA has achieved a net income surplus of \$24,596 which represents a 29% increase on the previous financial year.

- In 2021/22 the Association developed a new ETAWA e-commerce website. This has allowed for a smoother and more efficient payment system, improved member interface for event bookings and publication sales, increased on-line functionality and advanced analytics and reporting.
- Membership is now offered as a 12-month membership (from registration) rather than on a calendar year basis.
- The Association appointed *Morgan Bax Accounting* to develop and facilitate this change as they have significant experience with similar associations and clubs.
- Ongoing subscription to the CMS provider Oncord and to Secure Pay (Australia Post) has also been employed to accommodate the new e-commerce website.

Accounting

- In September 2021, the Association adopted XERO as the on-line accounting platform for its financial management.
- *Morgan Bax Accounting* was involved in setting this up and continues to provide ongoing support to the Association.
- This program will continue to improve and evolve over the 2022/23 financial year as the Treasurer becomes more adept at using the features of the XERO software.
- ETAWA now pays ongoing subscription to XERO.

Investment

- The Association holds a significant balance on behalf of its members (\$207,785).
- In the past ETAWA has relied on Term deposits to provide an additional source of interest income. In 2021/22 the rate dropped to approximately 0.05% on the amounts we had to invest which is the same as the interest achieved on the savings account.

- The Treasurer will continue to review the Associations investment strategy to see if there are other higher interest-bearing alternatives.
